STX's largest grocery chain no longer affiliated; owners to bid on St. Thomas store

ST. CROIX — A longstanding court battle surrounding the ownership of the territory's iconic supermarket chain Plaza Extra has resulted in a ruling by the Superior Court that virtually separates St. Croix's east and west stores, as well as establishing separate owners.

Christiansted's Plaza Extra East, and Frederiksted's Plaza Extra West, were divided in accor-

dance with the court order handed down March 5 by former judge Edgar Ross, who was appointed as "judicial master."

Court documents identify the plaintiffs as Fathi Yusuf and United Corporation and defendant Mohammed Hamed, whose authorized agent is listed as Waleed Hamed. Other members of the Hamed family and a corporation identified as Plessen Enterprises, Inc. also are named in court documents as defendants.

Both sides have filed lawsuits and counter claims against each other dating back to 2013, according to court documents.

The March 5 court order has brought at least one resolution. noted in court documents as the "Final Wind up Plan" or division of Plaza Extra West and Plaza Extra East, once owned by the Hamed and Yusuf families, who operated the two St. Croix locations, including the Plaza Extra in Estate Tutu on St. Thomas as far back as 1986.

Ross' order states "Hamed has lawfully and rightfully assumed full and sole ownership and control and may continue to operate Plaza Extra West without any further involvement of any other person or entity, using the trade name "Plaza Extra West."

In light of that ruling, Waleed Hamed, in a notice that includes Ross' order and issued to all doing business with his company, noted that effective 12:01 a.m., Monday "the business known as Plaza Extra West will be operated by KAC357. Inc., a Hamed company, which will do business as Plaza Extra West."

The Avis reached out to attorneys for both Yusuf and Hamed.

The Hamed family will own the Plaza West store and Mr. Yusufs family will own the East store," Joel Holt, the attorney for the Hamed family said in an interview Saturday with The Avis.

Both Nizar Dewood, an attorney for Yusuf, and Holt said their clients will have the right to appeal the Superior Court's ruling once the case has been completely resolved as there are matters still pending.

Holt, when asked whether the court's ruling could affect business. said it should not.

"I don't think the customers should notice a change because they have always run the two stores," he said. "They're just separating who runs each one."

Both parties also had applied for the right to bid on each other's store - in Christiansted and Frederiksted prior to the ruling, according to Holt.

Holt said the case is not completely resolved, as there is still the matter of the St. Thomas store and various claims relating to business expenditures.

The matter regarding ownership of that store will be addressed next week by Ross.

According to Holt each side -Hamed and Yusuf - will bid to buy out the other's stake in the St.

As part of the March 5 ruling. the court required Hamed to purchase from the Hamed-Yusuf Partnership, also known as the Plaza

satisfied the aforementioned he will "lawfully have sole right, title, interest, ownership and control of Plaza Extra West to the exclusion

of all other persons and entities that may have previously been involved in the operation of Plaza Extra West," according to the ruling.

Hamed also will have the right to operate the business under KAC357, Inc., a duly formed and

existing Virgin Islands corporation using the trade name "Plaza Extra West." The court order also noted it is

necessary that all governmental agencies, individuals and companies doing business with Plaza Extra West act with "all deliberate speed to recognize, document and

act in accordance with the directives of the Wind Up Order and this Order." Ross' ruling comes one week after the VI Supreme Court, on

Feb. 27, dismissed appeals by both Yusuf and Hamed, relative to earlier resolutions in the ongoing civil suit. The higher court's ruling allowed for the "Final Wind Up Plan" to go forward.

The Supreme Court's decision was handed down in response to a Jan. 5 appeal by Yusuf, objecting to Superior Court decisions.

One of those decisions, according to court documents was a July 22, 2014 opinion denying a motion to nullify various resolutions passed by the Board of Directors of appealer Plessen Enterprises,

Inc. and denying a request to

appoint a receiver for that corpo-

ration.

Yusuf also appealed a Dec. 5. 2014, opinion denving his motion for reconsideration of that earlier decision. Further, on Jan. 28, he filed

another notice of appeal, this time appealing a Jan. 9 Superior Court order adopting the "Final Wind Up Plan" relative to dissolving the partnership between him and Hamed to operate the three Plaza Extra stores territory-wide. On Feb. 9. Hamed filed a notice

of cross-appeal with the Supreme

Court. He said in court documents

he believed it lacked jurisdiction

over Yusuf's appeals, but that he

also wished to preserve his right to

challenge other aspects of the "Final Wind Up Plan" in the event the higher court concludes it does. in fact, have jurisdiction. The Supreme Court's associate justices ruled that it did not have jurisdiction citing the pending matters in the case still before the

Superior Court. The Hameds and Yusufs have run the Plaza stores since 1986 and in 2003, members of their

families were charged in U.S. District Court in connection with tax evasion, to which a plea agreement was entered in 2011.
