who physically drafted the check, when and where;

who signed the check, when and where;

who physically took that check to the bank, when and where

who that person dealt with at the bank, and any conversations,

what those funds were used for; and

a description and the amount of any check or withdrawals from that United account within 90 days of the deposit, in excess of \$10,000.

You have stated that you understand that Mike Yusuf either did or may have become a "de facto director" of Plessen. Describe in detail when and how you believe this happened – as well as the acts or facts that led to this.
