ORDER


THIS MATTER came before the Special Master (hereinafter "Master") *sua sponte*. On May 30, 2018, Parties filed a stipulation as to Hamed Claim No. H-3: Attorney's Fees of \$504,591.03 Paid to the Fuerst Law Firm in 2012-2013 (hereinafter "Stipulation"), where Parties agreed, *inter alia*, that the following two motions are mooted by the Stipulation: (1) Hamed's Motion for a Determination of 'No-Privilege' or to Compel Waiver or Presumption as to Hamed's Second Motion Regarding Claim H-3: Yusuf's Payments to the Fuerst Law Firm from Partnership Funds, filed on May 23, 2018; and (2) Hamed's Motion for Limited, 60-Day Enlargement of Time as [t]o Just the Depositions of Three Out-of-State Counsel: Regarding Claim H-3—Attorneys' Fees, filed on May 24, 2018. As such, the Master will grant the Stipulation and deny the aforementioned motions as moot. Accordingly, it is hereby:

ORDERED that Parties' Stipulation is **GRANTED**. It is further:

ORDERED that Hamed's Motion for a Determination of 'No-Privilege' or to Compel Waiver or Presumption as to Hamed's Second Motion Regarding Claim H-3: Yusuf's Payments to the Fuerst Law Firm from Partnership Funds, filed on May 23, 2018, is **DENIED AS MOOT**. And it is further:

ORDERED that Hamed's Motion for Limited, 60-Day Enlargement of Time as [t]o Just the Depositions of Three Out-of-State Counsel: Regarding Claim H-3—Attorneys' Fees, filed on May 24, 2018, is **DENIED AS MOOT**.
