ORDER

THIS MATTER is before the Master for review *sua sponte*.

On September 1, 2023, the parties filed a joint notice regarding status of claims.

Pursuant to the notice, the parties indicated that: (i) "Yusuf believes there are two Yusuf "B"

claims remaining" and "ask[ed] that he be allowed to submit these by November 1, 2023"; (ii)

"Hamed believes there are no Hamed "B" claims remaining which Hamed will pursue"; (iii)

"[w]ith regard to the "A" (Gaffney reviewed) claims, the spreadsheet reveals 67 outstanding

claims" and "Mr. Gaffney has asserted that he again has time to work on these"; (iv) "[w]ith

the submission of the final two filings by Yusuf on November 1st, it is expected the "B" claims

will be completed by the end of the year or shortly thereafter" and "[t]he "A" claims are a

function of Mr. Gaffney's ability to proceed as described." (Joint Notice, p.2).

On October 31, 2023, the parties filed an updated joint notice regarding status of claims.

Pursuant to the updated notice, the parties indicated that: (i) Yusuf "request[ed] that his

submission as to the remaining "B" claims be extended to November 30, 2023" and noted that

"Counsel for Hamed does not object to the extension of time"; and (ii) "it is still expected that

the "B" claims will be completed soon after the end of the year or shortly thereafter." (Updated

Joint Notice, p. 1).

On April 28, 2024, Hamed filed a motion for an order as to claims already addressed—

Order #11—to withdraw Hamed Claim No. H-279 with prejudice, which the Master

subsequently granted and struck Hamed Claim No. H-279 with prejudice.

There has been no other filing since April 2024. At this juncture, the Master will order

the parties to file an updated joint notice regarding status of claims. Accordingly, it is hereby:

ORDERED that on or before March 31, 2025, the parties shall file an updated joint

notice regarding status of claims. Parties shall list the remaining "A" claims by their specific

claim numbers and indicate which claims have been reviewed by Mr. Gaffney and which

claims still needs to be reviewed by Mr. Gaffney with an estimate of his completion dates. And it is further:

ORDERED that **on or before March 31, 2025**, Yusuf shall file his submissions for his two remaining "B" claims.
