**DEFENDANT ST. CROIX RENAISSANCE GROUP L.L.L.P.'S NOTICE
AS TO STATUS OF PETITION FOR WRIT OF CERTIORARI**

On May 17, 2013, the Third Circuit Court of Appeals entered an order and decision affirming this Court's remand to the V.I. Superior Court. U.S. Supreme Court Rule 13(1) provides:

RULE 13. REVIEW ON CERTIORARI: TIME FOR PETITIONING

1. Unless otherwise provided by law, a petition for a writ of certiorari to review a judgment in any case, civil or criminal, entered by a state court of last resort or a United States court of appeals (including the United States Court of Appeals for the Armed Forces) is timely when it is filed with the Clerk of this Court within 90 days after entry of the judgment. A petition for a writ of certiorari seeking review of a judgment of a lower state court that is subject to discretionary review by the state court of last resort is timely when it is filed with the Clerk within 90 days after entry of the order denying discretionary review.

On July 23, 2013 Defendant filed such a Petition.

Thereafter, on July 29, 2013, counsel for Plaintiffs notified the U.S. Supreme Court that they were waiving the filing of an opposition.

On August 7, 2013, that Court internally distributed the Petition for Conference of September 30, 2013.

Thereafter, on September 23, 2013, that Court directed Plaintiffs to file an opposition on or before October 23, 2013.

Plaintiffs then sought an extension -- which was granted until November 22, 2013.
