ORDER

On June 24, 2011, Defendant Century Aluminum Company ("Century") appeared in this matter through Bailey A. Calhoun, Esq. with the law firm of Ogletree, Deakins, Nash, Smoak & Stewart, LLC. Subsequently, on May 31, 2012, the Law Office of James L. Hymes, III, P.C., through James L. Hymes, III, Esq., appeared on behalf of Century. Then, on September 13, 2013, Century filed a stipulation to substitute the Law Office of James L. Hymes, III, P.C. in place of Ogletree, Deakins, Nash, Smoak & Stewart, LLC as counsel for record. So far as the Court can discern, that stipulation is still pending. It will be approved below. However, the Court also notes that on February 14, 2012, the Supreme Court of the Virgin Islands approved a petition Attorney Calhoun filed for the *pro hac vice* admission of Eric C. Schweizer as co-counsel for Century. (See Order, In re: Eric C. Schweizer, S. Ct. BA No. 2011-0221). A copy of the Supreme Court's order was docketed in this case the same day. A review of the record does not show whether Attorney Schweizer ever appeared in this case. Because David J. Cattie, Esq., with law firm of Ogletree, Deakins, Nash, Smoak & Stewart, LLC, has been copied on various papers filed in this case, the Court will direct him to inform the Court as to the status of Attorney Schweizer's admission pro hac vice.

Accordingly, it is hereby

ORDERED that the Stipulation for Substitution of Counsel filed by Defendant Century Aluminum Company on September 13, 2013 is GRANTED and Ogletree, Deakins, Nash, Smoak & Stewart, LLC is RELIEVED as counsel of record in this matter, *nunc pro tunc*. It is further

ORDERED that within fourteen (14) days from the date of entry of this Order, David J. Cattie, Esq. shall serve and file a notice regarding the status of the *pro hac vice* admission of Eric C. Schweizer
