OPPOSITION TO THE DEFENDANTS' PROPOSED DISCOVERY ORDER

The Plaintiffs' oppose the Defendants' Proposed Discovery Order filed with this Court as it is essentially just an order on Defendants' view of how discovery should be conducted as follows:

It assumes that the Court will agree that the failure to answer discovery within 200 days will result in a show cause order rather than the meet and confer and motion practice required by the Virgin Islands Discovery Rules. It does not provide that as an alternative ruling.

It does not provide a way for the Court to rule on the issue of using the prior discovery against all Defendants except SCRG to be used in this case or not.

Items number 4 in the order is an addition as to what will happen if alternative two is chosen by the Court as to additional depositions of the Plaintiffs and other issues that were not discussed or agreed to by the Plaintiffs.


